### Fees for New Students

- Nursery students entering JICS Lab School in Sept. 2024, tuition is \$18,723 + Enrolment Fee (See below)
- JK to Grade 6 students entering JICS Lab School in Sept. 2024, tuition \$29,092 + Enrolment Fee (See below)

# Fees for Current Students

2024-2025 Tuition for Full-Time JICS Lab School (JK to Grade 6) is \$ 29,092.

# **Enrolment Fee**

For **each new student** entering the JICS Lab School there will be a **one-time** Enrolment Fee, payable at the time of acceptance. The enrolment fee is **non-refundable**.

#### The Enrolment Fee is:

- \$5,000 for new students entering Nursery to Grade 2
- \$3,000 for new students entering Grades 3 and 4
- \$2,000 for new students entering Grades 5 and 6

## Included in Tuition Fees:

- Daily Snack (Nursery, JK, SK)
- Field Trips (excluding overnight trips in Grades 4 6)
- School Clubs and Sports Teams

## Not included in Tuition Fees:

- Daycare
- Wednesday Afternoon Program/Wednesday Afternoon Care
- Overnight Trips (Grades 4 6)
- Parents' Association Contribution
- Daily Snack (Grades 1 6)
- Hot Lunch Program

## **Tuition Support**

Families approved for JICS Lab School tuition support are notified by letter and the amount of the financial assistance award will be placed in the family's University of Toronto Fees Account by September 1, 2024.

## Payment Schedule

A non-refundable deposit of \$5,000 is due upon offer of admission or at re-enrolment in January. A second non-refundable payment representing 50% of the balance is due April 20, 2024. The remaining balance is due September 1, 2024. Any outstanding balances after September 1, 2024 will be subject to an interest charge of 18% per annum calculated monthly until the final payment has been received by the University.

## Payment Methods

- 1) **Cheque/Bank Draft:** Bring/send a cheque/bank draft to the School Office payable to the **University of Toronto**. Please write your UofT account number in the memo line.
- 2) Wire Transfer/EFT (option is only available after your family is issued a UofT ID Number):

  - b) Initiate wire transfer/EFT with your bank. Quote your UofT account number, during this process.
